

CORPORATION OF THE TOWNSHIP OF ST. CLAIR

BY-LAW NUMBER 27 OF 2023

Being a by-law to prohibit the parking of vehicles on Brigden Road between Courtright Line and 2916 Brigden Road

WHEREAS the Municipal Act 2001, S.O. 2001, C. 25, Section 11(3) allows a municipality to regulate the parking of vehicles on highways.

AND, **WHEREAS** the Municipal Council of The Corporation of The Township of St. Clair deems it desirable to regulate the parking of vehicles in specific areas in the interest of public safety and conveyance;

NOW, THEREFORE the Council of the Corporation of The Township of St. Clair enacts as follows:

- 1. No person shall park a vehicle on Brigden Road, from Courtright Line south to 2916 Brigden Road, better identified by Schedule 'B' to this Bylaw.
- 2. That NO PARKING signs be installed to identify this prohibited area.
- 3. Parking regulations shall be enforced when the appropriate signage has been erected.
- 4. That this by-law shall be considered to be part of the Townships comprehensive parking regulations and enforced accordingly.
- 5. That any other by-law or portion thereof in conflict with the provisions of this by-law shall be hereby repealed.
- 6. That this by-law come into effect upon the final passing thereof.
- 7. Every person who contravenes any provision of this bylaw is guilty of an offence and upon conviction is liable to a fine as provided for by s. 61 of the Provincial Offences Act, R.S.O. 1990, Chapter P.33, as amended.

If this By-law is contravened and a conviction entered, in addition to any other remedy and to any penalty imposed by the By-law, the court in which the conviction has been entered and any court of competent jurisdiction thereafter may make an order prohibiting the continuation or repetition of the offence by the person convicted.

READ the first, second and third time and finally passed this 1st day of May, 2023.
